9. PROCESS ACCEPTED BALLOTS THROUGH THE HIGH SPEED TABULATORS.
10. PROCESS ELECTION DAY RESULTS.
11. DETERMINE STATUS OF PROVISIONAL BALLOTS CAST.
12. CANVASS/PROCESS REMAINING ABSENTEE BALLOTS, UNSCANNED BALLOTS AND PROVISIONAL BALLOTS, IF ANY.
13. REVIEW AND SIGN CERTIFICATION OF TABULATION SOFTWARE AND FIRMWARE VERSION NUMBERS.
14. CERTIFY ELECTION RESULTS AND SEAL RECORDS.
15. IF ALL PROVISIONAL BALLOTS HAVE BEEN CANVASSED, ADVISE THAT THE MEETING SCHEDULED FOR DECEMBER 13, 2018 WILL BE CANCELLED.
16. ANY OTHER BUSINESS.
17. ADJOURNMENT.
