- 3.1. **Update on Case 17-00007, Mark O'Brien, Taylor Rental Center** – Attorney Bach was unable to attend this meeting to give an update.

4. **New Business**

- 4.1 **Walter I. Champion Estate, 221 S. 5<sup>th</sup> Street, Case Number 17-00007**

Violation of the City of Fernandina Beach, Code of Ordinances, Section 42-116 (a), Cleaning of lots; maintenance of structures, and that the respondent pay the administrative fees incurred. Requesting Board determination of the case.

Michelle Forstrom, Code Enforcement Manager read the Staff Report and gave the history of the case.

Bryan McCarthy, 204 S. 18<sup>th</sup> Street, Fernandina Beach stated the family has been working very hard to clean the yard and maintain the home. He and his wife have a dumpster on site. With Hurricane IRMA in site this weekend he is asking for an additional week to complete the cleaning of the yard. He explained the difficulty of the present situation with family members.

A motion was made by Member Kauffman that the property was found in violation of the City of Fernandina Beach, Code of Ordinances, Section 42-116 (a), Cleaning of lots; maintenance of structures, and that the respondent will have no fees assessed and recover administrative fees not to exceed \$300.00. **Action:** Approved, Moved by Member Kauffman, **Seconded by** Member Crow.

**4.2 Michael Richardson, 314 Elm Street, Case Number 17-00024**

Violation(s) of the City of Fernandina Beach, Code of Ordinances, Section 42-116 (a & b), cleaning of lots; maintenance of structures; and 42-173 Wrecked or inoperable motor vehicles on private property declared a nuisance and prohibited. Requesting Board determination of the case.

Michelle Forstrom, Code Enforcement Manager read the Staff Report and gave the history of the case.

Michael Richardson, 314 Elm Street explained he has a friend that has been dumping items on the property for some time. He asked if he could have an extension due to Hurricane IRMA heading this way. After much discussion he explained he would bring the property into compliance.

The Board had a brief discussion on what timeframe to allow Mr. Richardson to come into compliance. A motion was made by Member Kauffman that the property was found in violation of the City of Fernandina Beach, Code of Ordinances, Section 42-116 (a & B), cleaning of lots; maintenance of structures; and section 42-173 wrecked or inoperable motor vehicles on private property declared a nuisance and prohibited. Impose fines of \$100.00 per day, per violation until property comes into compliance beginning September 26, 2017 for cleaning of lot and moving the wrecked or inoperable vehicles; and November 1, 2017 for the maintenance of the structure and recover administrative fees. **Action:** Approved, **Moved by** Member Kauffman, **Seconded by** Member Crow.

Summary and Background Information

**August 10, 2017**, Proactive sweep observed and confirmed an inoperable vehicle (Silver Nissan) untagged on the front driveway.

**August 10, 2017**, I left a door hanger on the front door giving the occupant a written warning of ten (10) days to correct the violation. Took pictures.

**August 21, 2017**, 2<sup>nd</sup> inspection of property revealed no change in violation. I gave an extension to 9/4/17 to correct.

**September 18, 2017**, 3<sup>rd</sup> inspection of property on field visit showed no correction of violation.

**September 19, 2017**, I mailed out NOV/NOH letter via certified mail to owner. It came back refused.

**October 18, 2017**, I hand delivered a copy of the NOV/NOH letter to tenant at 507 S. 16<sup>th</sup> St. I posted a NOV/NOH letter at owners address at 1543 N. Fletcher Ave on the front door. I took a picture of posting.

Conclusion

I spoke with the tenant that is living in this house on three (3) different occasions about this violation. No correction has been made to date.

Recommendation

Staff recommends a \$100.00 per day fine for the violation, along with administrative fees incurred.

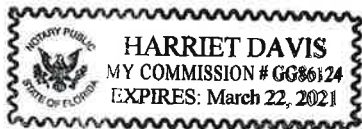


