AWARD PROGRAM INFORMATION

The award program partners wish to recognize the efforts of those involved in preserving our unique architectural resources. Historic structures contribute to the identity of our community, and sensitive treatment of these resources ensure future residents and visitors will experience the same community character. **Award winners will be presented at a ceremony May 9, 2019.**

AWARD CATEGORIES

Projects will be assigned a category by the judges. More than one award in a category may be awarded.

- Restoration/Rehabilitation - Properties that have been restored to their original style or appearance.
- Sensitive Addition - Construction of an addition that is compatible with the original architectural style of the property.
- New Construction - New structure that is compatible with the historic district.
- Storefront Façade Renovation - Projects that demonstrate sensitive treatment of historic storefronts.
- Craftsmanship - Technique or method of construction considered unique or rare by today's methods.
- Preservation Champion - Celebrating an individual(s) dedicated to preserving Fernandina Beach's heritage.
- Keystone Award - Presented to the project that best represents Historic Preservation. All project submissions will be considered for this award.

ELIGIBILITY

Any individual or organization and **any structure within City limits** are eligible. Only exterior improvements are eligible, except for craftsmanship. Projects must have begun in the last **FIVE** years and **completed no later than 3/15/19**. Prior award winners are not eligible to apply for the same projects.

JUDGES

The Awards Committee for the preservation awards will consist of five members drawn from organizations/offices such as: the Amelia Island-Fernandina Restoration Foundation, Amelia Island Museum of History, the Florida Trust, Riverside-Avondale Preservation, Jacksonville Historical Society, and practicing Florida architects.

JUDGING CRITERIA

Nominations will be evaluated on the following as applicable:

- Compliance with Secretary of the Interior Standards for the Treatment of Historic Properties;
- Contribution of the project or person to preservation of Fernandina's historic resources;
- Impact of the project or person on the community;
- Level of difficulty of the project; and
- Historical and architectural significance of the property preserved by the project.

If no projects submitted for the respective categories meet the complete judging criteria as determined by the judges, no award will be given for that category. Award decisions are final and not appealable.

NOMINATION SUBMITTALS

Nomination forms are available through the City's website (www.fbfl.us/PreservationAwards), and in the Department of Planning & Conservation lobby in City Hall (204 Ash St). There is **no fee** to submit a nomination. Nominations must be submitted no later than **Friday March 29, 2019**. Fax transmissions are not accepted. Nomination packages will not be returned. All nomination materials, including photographs, become the property of the City and its partner organizations, and may be reproduced by the City or the partner organizations without additional permission. The City reserves the right to disqualify any nomination that is incomplete or does not meet the requirements.

AWARD CATEGORY CRITERIA AND APPLICATION REQUIREMENTS

Application packages should include the following items, as well as any additional plans, elevations, letters of support, etcetera that support your application:

▪ **Restoration/Rehabilitation**

Acknowledges proper rehabilitation of a structure according to the Secretary of the Interior Standards. Project may include exterior improvements that respect the historic integrity of the structure or adaptive reuse of a building. Application must include:

- Brief description of the project, which may include history of the building, discussion of the building before and after restoration and rehabilitation, and any special conditions addressed during the project.
- Color photographs illustrating the project before and after work.

▪ **Sensitive Addition**

Recognizes additions exemplifying compatibility with the original historic structure. Application must include:

- Brief description of the project, including how the design of the new addition is in harmony with the primary structure.
- Color photographs illustrating the project before and after work.

▪ **New Construction**

Awarded for sensitive design and careful construction of a new structure in either the Old Town or Downtown Historic Districts. Application must include:

- Brief description of the project, including how the design of the new structure is in harmony with its historic surroundings.
- Color photographs depicting work in progress, finished structure, and surrounding buildings.

▪ **Storefront Façade Renovation**

Awarded in recognition of projects creating a positive contribution to the streetscape and respectful treatment of historic aspects of the building. Application must include:

- Brief description of the project, including a history of the building, and how the improvements positively contribute to the streetscape.
- Color photographs depicting the project before and after work, and a photograph of the building in relation to surrounding structures.

▪ **Craftsmanship**

Recognizes traditional method of construction, included but not limited to wood working, wrought-iron work, framing, or plastering, and recognition of the craftsperson that completed the work. This category may include interior work. Application must include:

- Brief description of the project, including information about the craftsperson's trade and their experience.
- Color photographs of the project.

▪ **Preservation Champion**

Awarded to an individual(s) who has demonstrated a commitment to the preservation, protection, and enhancement of Fernandina Beach's historic and cultural resources. Application must include:

- Description of the person(s) contributions to the preservation of Fernandina Beach's cultural and historic resources.

▪ **Keystone Award**

Awarded to the project that is deemed to be the best example of Historic Preservation. All project submissions will be considered for the Keystone Award.
